2. Calculated by multiplying the total number of the Offshore Preference Shares issued by the issuance price of each Offshore Preference Share, being U.S.\$20 each.

3. Calculated based on the aggregate of ordinary share capital and the total proceeds raised from the issuance of all Offshore Preference Shares, which is converted into Renminbi at the CNY Central Parity Rate between U.S. dollars and Renminbi of RMB6.6322 to U.S.\$1.00 as published by the China Foreign Exchange Trading Centre on 25 October 2017.

4. The initial conversion price of the Offshore Preference Shares is equal to the average trading price of H Shares of the Bank for the 20 trading days prior to the announcement date of the Board resolution approving the proposed issuance of the Offshore Preference Shares (24 March 2017), namely HK\$21.06 per H Share. The number of H Shares issuable upon full conversion of the Offshore Preference Shares is calculated by dividing the total offer size of Offshore Preference Shares (as converted into Hong Kong dollars at the fixed exchange rate of US\$1.00 to HK\$7.7672) by the initial conversion price of HK\$21.06 per H Share, rounded down to the nearest whole number of H Shares.
